### **Legal Scholarship Works in Progress**

*Decarceral Constitutionalism*. This paper introduces the concept of decarceral constitutionalism to legal scholarship. The concept refers to social movements that check government power to police, prosecute and punish, and do so in ways that can strengthen constitutional criminal procedure rights. The paper highlights differences between decarceral constitutionalism and movements discussed by popular constitutionalist scholars, and explains how decarceral constitutionalism works through a case study of the participatory defense movement.

*Democratizing the Sixth Amendment*, \_\_\_ INDIANA LAW REVIEW \_\_\_ (2017). This essay will build *The Antidemocratic Sixth Amendment*, 91 WASHINGTON LAW REVIEW 1705 (2016) by discussing recent empirical analysis of a pilot project in Comal County, Texas, that pioneered an attorney choice program for indigent defendants and by exploring the implications of the resulting data for the equal vindication of the Sixth Amendment right to choose counsel for rich and poor alike.

*The Cone of Silence*, \_\_\_ MERCER LAW REVIEW \_\_\_ (2018). This co-authored paper (with Ellen Yaroshefsky and Andrew L.B. Davies, Ph.D.) will analyze ethical concerns that arise when empirical research on public defense implicates attorney-client communication and related doctrines governing confidentiality and privilege. After explaining potential problems, the paper will discuss possible solutions and their limitations.

*Defining and Assessing Quality Attorney-Client Communication and Empirical Research on Public Defense: Some Lessons on Process*. These co-authored papers will build on my prior publications, including *Unnoticed, Untapped, and Underappreciated: Clients' Perceptions of their Public Defenders*, 33 BEHAV. SCI. & L. 751 (2015) (second author, with Christopher C. Campbell, Wesley Meier and Michael Gaffney), by deepening prior mixed-methods empirical investigations into the definition and assessment of quality public defense and,

more specifically, into quality communication between public defenders and people who are dealing with criminal charges but cannot afford to hire counsel.

*Grassroots Originalism.* This paper highlights the absence of poor people from the polity that scholars and judges consult when interrogating “original understandings” of constitutional meaning. Analysis focuses on and problematizes the originalist justifications for excluding poor people from the right to choose defense counsel, which the Supreme Court has held to be the “root meaning” of the Sixth Amendment right to counsel.

*From Reentry to No Entry: Asset-Based Organizing for Research-Based Policy Reform* (Principal Investigator). Supported by a \$75,000 grant from the Ohio Transformation Fund, this project will investigate the views of residents in highly-policed communities on their definitions of public safety while offering training on leadership development and data analysis to effect policy reform.

*Reducing Mass Incarceration by Improving Public Defense: Defining and Assessing Quality Attorney-Client Communication* (Principal Investigator). With support from a \$25,000 grant from the University of Cincinnati Research Council, this pilot study will investigate the views of public defense lawyers and people who need public defense representation regarding factors that promote and impede quality communication in that setting.

*Survey of Public Defenders: A Design Study* (Expert Panel Member). With support from a \$500,000 grant from the U.S. Department of Justice Bureau of Justice Assistance to the Urban Institute, the National Association for Public Defense, and the Indigent Defense Research Association, this project will investigate the views of public defense providers, people who need public defense, and researchers on the design of a national public defense survey.
